- 1) COPY OF PARENT(S) AND GUARDIAN(S) DRIVERS LICENSE
- 2) COPY OF CHILD(REN) BIRTH CERTIFICATE
- 3) FILING FEE OF \$200.00
- 4) TO HAVE PETITION NOTARIZED IN OUR OFFICE **EVERYONE** EXCEPT THE CHILD(REN) MUST BE PRESENT
- 5) PETITION MUST BE TYPED, ON LEGAL PAPER AND DOUBLE SPACED
- 6) THE JUDGMENT ATTACHED CAN BE COMPLETED AND RETURNED WITH THE PETITION.
